The Doctor of Business Administration (DBA) is a professional doctorate for experienced leaders and managers who want to combine advanced leadership skills with practical research. It focuses on applying academic ideas to real business problems so candidates can lead change and create evidence-based solutions.

The Doctorate of Business Administration (DBA) at EU Global is a Level 8, fully accredited doctoral degree on the Malta Qualifications Framework and the European Qualifications Framework. The program requires candidates to produce original work that advances knowledge or practice in their field through independent research or the innovative application of existing knowledge.

### Purpose and Focus

The DBA develops the ability to combine rigorous analysis with practical problem-solving. It prepares experienced professionals to investigate complex organizational challenges, design evidence-based solutions, and apply findings to improve practice and policy. The program emphasizes research that has clear relevance to industry, public organizations, and professional practice.

### Candidate Profile

The program is intended for senior managers, executives, consultants, and experienced practitioners who already hold a master's degree or have equivalent professional experience. Candidates are expected to bring subject-matter expertise and a clear professional context for their research.



# Research Topics and Flexibility

Candidates may pursue research in any area where they have prior expertise, including but not limited to marketing, finance, technology, operations, human resources, data analytics, healthcare, and agribusiness. Supervisors work with each candidate to define a research question that is both original and practically meaningful.

## Program Structure and Learning Pathway

Andragogical approach for the doctoral program.

EU Global's Doctor of Business Administration applies adult learning principles to help candidates achieve maximum research and professional impact. Delivered in staged phases with clear milestones, the program lets scholars build their thesis progressively.

The doctorate at EU Global is organized into three stages:

# Stage 1

## Professional Reflection and Research Foundation

Milestone 1: Professional reflection and application to practice

- i. DOC 101 Strategic Leadership and Innovation for Sustainable Development — links leadership practice with sustainable and innovative strategies.
- ii. DOC 102 Professional Review and Translating into Research — converts professional experience into researchable problems.
- iii. RES 101 Research Objectives Proposal Writing and Ethics — develops research questions, drafts proposals, and secures ethical approval.

Key outputs: reflective portfolio, initial proposal draft, ethics clearance





# Stage 2

## Proposal Development and Methodology

Milestone 2: Research proposal and defense

- i. DOC 103 Literature Review for Doctoral Studies — methods for reviewing and positioning research within existing knowledge.
- ii. DOC 104 Advanced Research Methodologies — advanced qualitative, quantitative, and mixed methods for applied research.
- iii. RES 102 Academic Publications — guidance on preparing work for journals and planning dissemination.

Key outputs: completed literature review, final research proposal, and formal proposal defense.



### Exit Award / Qualification

An interim award of Master of Philosophy (MPhil) is granted to scholars who have completed the research coursework.

# Stage 3

## Research Execution and Thesis Completion

Milestone 3: Dissertation submission and defense

- i. DOC 105 Data Collection — practical approaches to gathering primary and secondary data.
- ii. DOC 106 Data Analysis and Interpretation — tools and techniques for analyzing results.
- iii. DOC 107 Discussion Conclusions and Recommendations — linking findings to practice and policy.
- iv. DOC 108 Writing and Structuring Dissertation — thesis structure, academic writing, and presentation.
- v. RES 103 Dissertation Submission and Viva Preparation — final submission checks and viva preparation.

Key outputs: completed thesis (target 60,000 words), submission, viva voce.





# Supervision Assessment and Support

- **Supervision:** Each candidate receives a dedicated supervisor and regular progress reviews.
- **Assessment:** Module assignments, proposal defense, publication activity, thesis submission, and oral defense.
- **Support services:** Research seminars, online library access, statistical and qualitative analysis help, and peer cohorts

## Progression Duration and Outcomes

- **Progression:** Module work feeds directly into the thesis to ensure continuous development.
- **Study duration:** Two years (24 months)
- **Outcome:** A practice-focused doctoral thesis that makes an original contribution to knowledge and offers actionable recommendations for professional practice.



## Learning Outcomes

On completion of the Doctor of Business Administration, EU Global scholars will be able to:

- **Create and advance knowledge.** Analyze complex problems and produce original research or scholarship that extends the discipline and is suitable for peer-review publication.
- **Master current knowledge.** Acquire and organize a substantial, up-to-date body of knowledge that sits at the leading edge of their professional field.

- **Uphold research integrity.** Recognize ethical issues, follow institutional and disciplinary ethical standards, and conduct research with honesty, transparency, and respect for participants.
